#### Location

Mason Place Business Park is very well located to the east of Derby City Centre and less than one mile from Pentagon Island. There is good road connectivity to local road networks with easy access to the A38 and A52 trunk roads connecting with J28 and J25 of the M1 respectively.

The A52 also provides access to the A50, via Raynesway, which connects J23a of the M1 at Kegworth with J15 of the M6 at Stoke.

### The Site

The premises comprise two a tarmacadam surfaced site extending to approximately 460 sq m, or thereabouts, with extensive frontage to Nottingham Road.

The site is accessed via the main service road providing access into Masons Place Industrial Park

Previously used as car parking pans, the plot are suitable for a variety of other uses – subject to obtaining any necessary planning permission.


