#### Location

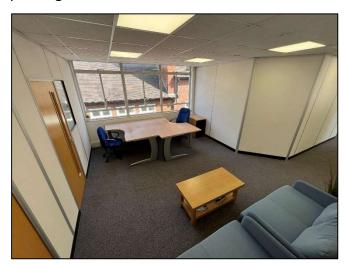

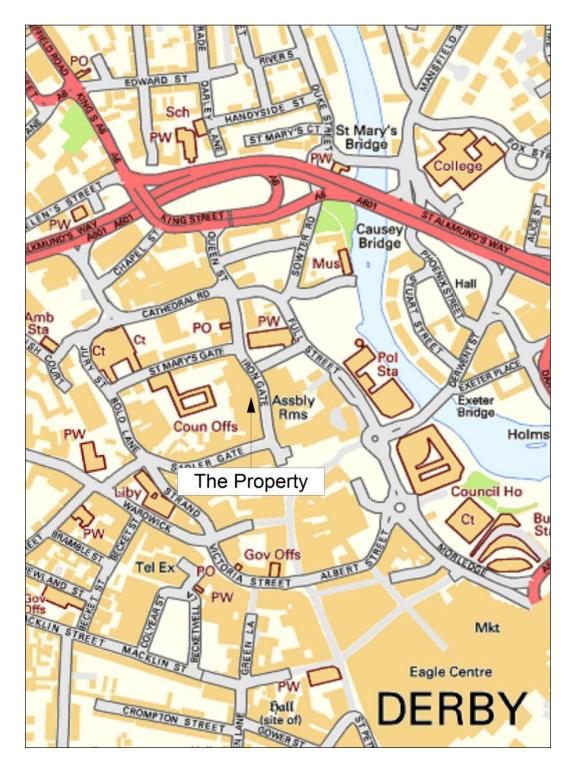
