

# **TO LET** General purpose, town centre business premises at 8a, Newbury St, Wantage in southern Oxfordshire.



## **General description**

"The Gallery" offers a distinctive and open plan retail space at ground floor level of this Listed Building. The unit also benefits from an upper floor room with adjoining WC, which would provide suitable staff facilities. Use Class E: Commercial, Business and Service premises pre-permitted for a variety of uses. The unit already has Listed Building consent for "Change of use of the property [to a Restaurant/Café], fixing ventilation grille, internal alterations to replace decoration and provide seating and bar/kitchen facilities" (see Agent's note overleaf).

## **Location**

The historic market town of Wantage, along with nearby Grove, is located in affluent southern Oxfordshire and both are growing rapidly in population terms which is set to continue for several years yet. Wantage is approximately 15 miles southwest of Oxford at the junction of the A338 and A417, approx. 6 miles west of the A34 "Milton interchange" near Didcot.

The premises are located on the west side of busy Newbury Street which is the sole route in/out of the town centre from the south, adjacent to the junction with Church Street and a short walk from the public car park off Church St.

## **The accommodation**

Open plan on both floors but of slightly irregular shape on the ground floor (please refer to the floorplan overleaf and for approximate dimensions). The overall internal floor area is approx. 745sq.ft/69.2sq.m. A range of works are due to be carried out prior to new occupants, further details available upon request.

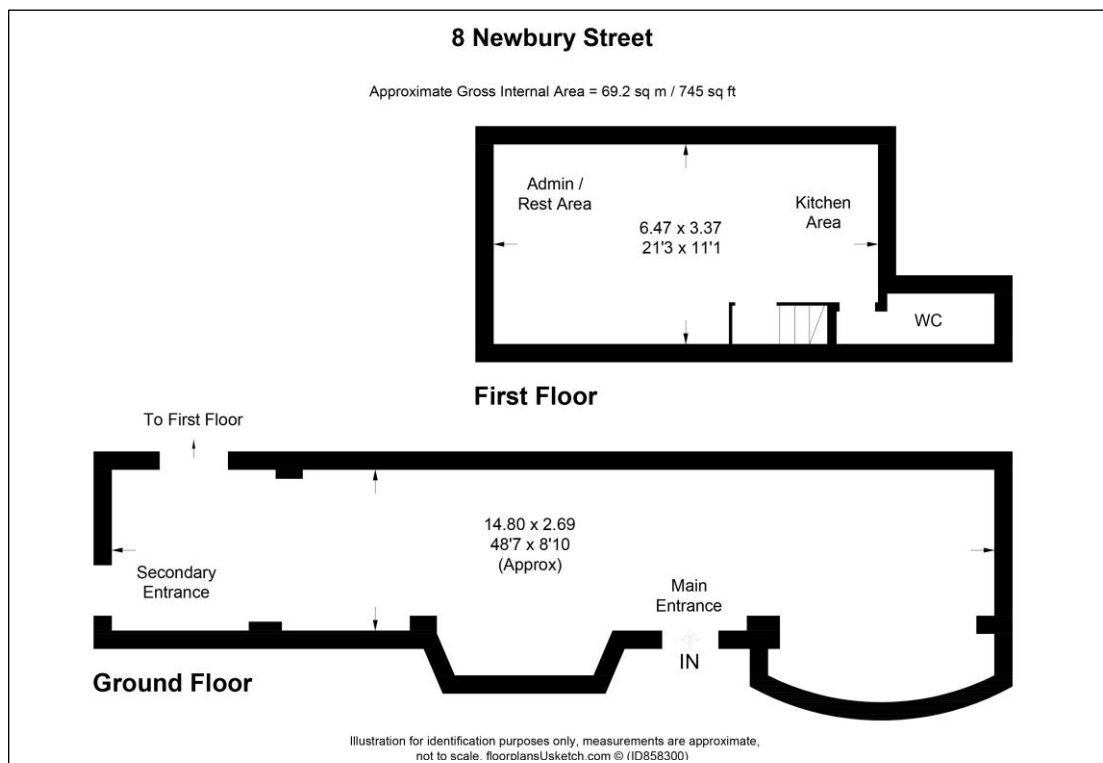
