# Description

The unit comprises an end terrace industrial / storage unit of block/brick/cladding elevations beneath a pitched roof.

Internally the property comprises an open span unit with a WC; there is a mezzanine store and small mezzanine office above.

The roller shutter door is 3.0m x 4.9m and the unit has a minimum eaves of 5.35m.

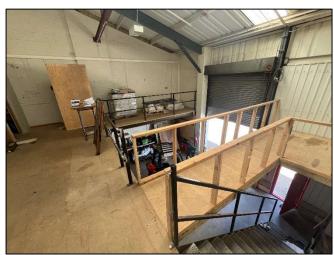
