Location

The Derby West Business Centre is located on the A52 (Ashbourne Road) approximately 4 miles to the west of Derby City Centre. The A52 is a main arterial route that connects Derby with the market town of Ashbourne. The location is therefore uncongested and offers a rural aspect yet vehicular accessibility to Derby and the outer ring road / A38 is excellent.

The adjacent Mundy Arms public house (Premier Inn) and nearby Mackworth Hotel offer lunchtime and evening dining and overnight accommodation.

Description

The property comprises an imposing modern office building that is offered to let on the basis of individual rooms and suites, on 'all inclusive' terms. There are shared reception and waiting room facilities.

To the outside, the property has a forecourt for parking and further areas to either side for parking.

There is no charge or contribution to buildings insurance. However, individual tenants are responsible for the insurance of the contents of their own offices.


Legal Costs


